Last day to file petition for public question (certain exceptions apply).

First day for mailing or delivery of vote by mail ballot.

EARLY VOTING

Last day for registration or transfer of registration within the offices of the election authority.

Last day the township board shall publish a notice stating the time and location of the caucus for each political party.

NOVEMBER 22, 2020

PUBLICATION – MULTI-TOWNSHIP CAUCUS

Last day the multi-township central committee shall publish a notice stating the time and location of the caucus for each political party.

NOVEMBER 27, 2020

PUBLICATION - MUNICIPAL CAUCUS

Last day for municipal clerk to publish notice of municipal caucus in municipalities with population over 500 (in municipalities with a population of under 500, notice shall be given by municipal clerk posting the notice in three of the most public places in the municipality).

DECEMBER 1, 2020

TOWNSHIP CAUCUS

Date on which the Township Caucus shall be held (in those townships which have not adopted the primary system).

DECEMBER 2, 2020

Last day to adopt a resolution or ordinance for binding/advisory public question.

JANUARY 28, 2021

BALLOT CERTIFICATION

Last day for the local election official to certify candidates and the offices they are filing for to the election authority.

FEBRUARY 4, 2021

WRITE-IN CANDIDATES

Last day to file a Declaration of Intent to be a write-in candidate with the appropriate election authority or authorities (61 days prior to the election).

FEBRUARY 19, 2021

VOTE BY MAIL - UOCAVA

Last day for the election authority to have sufficient number of ballots available for mailing to persons in the United States Service, their spouse, and/or their voting age dependents, as well as for citizens temporarily residing outside the territorial limits of the U.S. and nonresident civilians.

First day for mailing or delivery of vote by mail ballot.

EARLY VOTING

Last day for registration or transfer of registration within the offices of the election authority.
